ADOPTING PROPOSED PROCEDURAL SCHEDULE,
NOTICE OF HEARING ON THE MERITS,
AND REQUIRING STATEMENT ON NEED FOR COURT REPORTER

I. ADOPTING PROPOSED PROCEDURAL SCHEDULE

On September 2, 2016, the City of Cibolo (City), Green Valley Special Utility District (Green Valley), and Staff of the Public Utility Commission of Texas filed an agreed proposed procedural schedule, which is adopted and shall govern in this case:

II. NOTICE OF HEARING ON THE MERITS

The hearing on the merits is set to begin at **9:00 a.m., January 17, 2017**, at the State Office of Administrative Hearings, 300 West 15th Street, 4th Floor, Austin, Texas. The hearing is expected to last for two days.

III. REQUIRING STATEMENT REGARDING COURT REPORTER

As noted in SOAH Order No. 2, the parties estimate that the hearing on the merits will last longer than one day. Under 1 Texas Administrative Code § 155.423(b),¹ for any proceeding set to last longer than one day, a court reporter is generally required. **No later than October 3, 2016, the parties shall confirm that a court reporter will be provided at the hearing and address how the court reporter's fees will be paid.** The ALJ notes that in proceedings before the Commission, Kennedy Reporting Services, Inc. is used.
