## SOAH ORDER NO. 4 SETTING PREHEARING CONFERENCE IF REQUESTED, CHANGING RELATED DATES, AND SETTING DEADLINE FOR RESPONSES TO MOTION FOR PARTIAL SUMMARY DECISION

Administrative Law Judge (ALJ). Elizabeth Drews is co-assigned to this case with Judge Travis Vickery and will be the ALJ primarily responsible for this case.

## I. SETTING PREHEARING CONFERENCE IF REQUESTED AND CHANGING RELATED DATES

SOAH Order No. 3 provided that a prehearing conference would be held on January 10, 2017, if requested by January 6, 2017. Due to conflicts in the ALJs' schedules, instead the prehearing conference will be held on January 13, 2017, at 9:00 a.m., if requested in a filing no later than January 11, 2017. If a prehearing conference is requested, it will be held at the State Office of Administrative Hearings, 300 West 15th Street, 4th Floor, Austin, Texas, unless a joint request to conduct it by telephone is filed no later than January 11, 2017. Any such request to hold a prehearing conference or to conduct it by telephone is automatically GRANTED. Matters to be considered at the prehearing conference include any matters listed in the request, any pending motions and objections, matters relating to the hearing on the merits, and any other matters that may assist in fair and efficient disposition of the proceeding. If the parties request a telephonic prehearing conference, the ALJs will initiate it by calling the phone numbers on the service list unless a different phone number has been



provided **no later than January 11, 2017**, either in a filing or by contacting Erin Hurley at (512) 475-3419 or <a href="mailto:Erin.Hurley@soah.texas.gov">Erin.Hurley@soah.texas.gov</a>.
