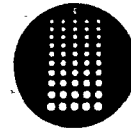

4. A list of the customers who received refunds is attached hereto as Exhibit A.

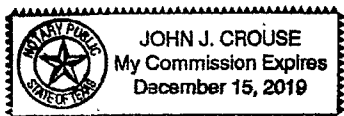
