**COMMISSION STAFF'S REQUEST TO AMEND PROCEDURAL SCHEDULE**

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Request to Amend Procedural Schedule, and would show the following:

**I. BACKGROUND**

On March 11, 2016, Villas of Willowbrook Homeowners Association, Inc. (Willowbrook) and Monarch Utilities I, L.P. (Monarch) (collectively Applicants) filed an application for the sale, transfer, or merger of facilities and certificate of convenience and necessity rights in Harris County. On January 6, 2017, Order No. 6 was issued, requiring that Staff provide final maps, certificates, and tariffs to applicant for review and consent by February 6, 2017, that the applicant file signed consent forms with the Commission by February 20, 2017, and that the parties file joint proposed findings of fact and conclusion of law by February 27, 2017.

**II. REQUEST TO AMEND PROCEDURAL SCHEDULE**

During Staff's review of the final documents, Staff discovered issues with the tariff that must be addressed before the tariff can be approved. Staff requests that the procedural schedule be amended as follows:

Event	Date
Deadline for Staff to provide final maps, certificates, and tariffs to Applicant for review and consent	March 8, 2017
Deadline for Applicant to file signed consent forms with the Commission	March 22, 2017
Deadline for parties to file joint proposed findings of fact and conclusions of law	March 29, 2017


