It is obvious to even the most casual observer that Rio Concho water is simply using "expenses" as a method to extract income from Rio Concho water customers. After examining the financials provided by Rio Concho it appears the company can show a profit that well exceeds the PUC guidelines without an increase to the current rates. Rio Concho is over compensating its one employee with not only the salary for a part time job but also by providing a luxury automobile, a life insurance policy, medical insurance and a retirement annuity. These expenses are all well above what other small and many very large companies provide for their employees.

Rio Concho has again filed for a rate increase just a little more than a year after their last rate increase. The manufacturing of an increase in expenses to justify their proposed rate increase is not ethical. The claimed benefits that are optional employee-paid benefits in large companies, are being expensed 100% to the ratepayers without any employee contribution at Rio Concho, a one-person company. For all the water customers of Hicks Airfield, I request the PUC and the ALG to do their due diligence and investigate Rio Conchos expense clams and deny those that are out of line.

Rio Concho has filed 3 water rate increases in the last 3 years. If the full rate request is granted, revenue will increase by almost \$59,000 compared to 2013 water revenues or an increase of 63.3% with no increase in meters. Clearly their expenses have runaway. Salaries, benefits, affiliated transactions, capital expenditures, auto expenses and numerous other expenses must be reduced.
