The City of Portland has been notified that the Rincon Water Supply Corporation has withdrawn its objection to the City's CCN amendment application and Rincon's request for a public hearing. However, Rincon filed the withdrawal request, which is attached for your review, under the incorrect docket number.

As a result of Rincon's withdrawal request, the City of Portland would respectfully request the public hearing be dismissed. Alternatively, if a prehearing conference is still required to discuss the case, we respectfully request that the prehearing date be moved to the week of March 27 and that the prehearing occur via teleconference. 
(3)We, Rincon Water Supply Corporation, wish to withdraw our request for a public hearing in the matter of the above listed cause.
