



STAFF'S UPDATED STATUS REPORT

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files this updated status report. In support thereof, Staff shows the following:

I. Background

On March 29, 2016, City of Portland. (Portland) filed with the Commission an application (Application) to amend Certificate of Convenience and Necessity (CCN) No. 20216 in San Patricio County pursuant to Tex. Water Code Ann. (TWC) §§ 13.242-50 and 30 Tex. Admin. Code (TAC) §§ 291.101-07.

SOAH Order No. 6, issued March 16, 2017, required Staff and Portland to file an updated status report by March 31, 2017. Thus, this pleading is timely filed.

II. Status Report and Proposed Procedural Schedule

Staff is in the process of preparing final maps and a recommendation. Staff, after consultation with Portland, proposes the following procedural schedule to allow this case to proceed to conclusion efficiently and expeditiously:

Deadline for Staff to provide final maps, certificates, and tariffs (if applicable), to Applicant for review and consent	May 4, 2017
Deadline for Applicant to file signed consent forms	May 18, 2017
Deadline for Staff to file a final recommendation on the Application	May 25, 2017
Deadline for parties to file joint proposed findings of fact and conclusions of law, a motion to admit evidence and remand, and any other necessary documents.	June 15, 2017

III. Conclusion

Staff recommends the ALJ enter an order adopting the procedural schedule proposed above.
