STAFF'S MOTION TO SWITCH DOCKET NUMBERS AND FOR EXTENSION OF TIME

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files Motion to Switch Docket Numbers and for Extension of Time and would show the following:

I. Background

On May 3, 2016, Order No. 2 was issued, requiring the City of Portland (Portland) to provide notice pursuant to 16 Tex. Admin. Code § 24.106 (TAC) and to file proof of notice with the Commission. According to Portland's affidavit, Portland issued the required notices; however, the notices misidentified the docket number as 45782 instead of the correct number, 45781. Order No. 2 also requires Staff to provide an updated procedural schedule by June 10, 2016.

II. Motion to Change Docket Numbers

Staff respectfully requests that the administrative law judge (ALJ) issue an order changing the docket number of this proceeding from 45781 to 45782. This would prevent the delays and expense associated with reissuing notice. Staff has confirmed with Shawn Hazard of Central Records that docket number 45782 is not currently in use but that an order from the ALJ is necessary to change the docket number. Staff has spoken with Brian DeLatte of the City of Portland, and Portland supports Staff's request.

III. Motion to Extend Time

Due to a family emergency, Staff respectfully requests an extension of time of time for filing the proposed procedural schedule, currently due on June 10, 2016. Staff requests June 24, 2016 as the revised deadline to file an updated procedural schedule. Staff is authorized to represent that Portland does not object to this request.
