To Whom It May Concern:

As an owner of the property listed below, we formally request a public protest hearing for the aforementioned proposed CCN, which has been submitted for review without our consent or knowledge. We were **NOT** notified by the applicant of this proposed CCN nor requested to provide our feedback as to its impact on our property.

Therefore, in addition to requesting a public protest hearing, we request an extension of the deadline to consider this proposed CCN so that all property owners within affected subdivision that are not part of the Applicant's subdivision can be properly notified and public hearings can be held to discuss this CCN.

It is our desire to **NOT** be included in this proposed CCN since we have land that is adequate under the TCEQ and Navarro County to accommodate a licensed septic system, therefore there is no need or benefit to being a part of this CCN. This CCN, if converted to a MUD would only serve the purpose of imposing a tax against us as property owner, for a sewer service that would not be required for our property or subdivision, when we can adequately and legally install a licensed septic system to service our property.

In lieu of our request for hearing to protest this proposed CCN or an extension for its review, we simply request the application be modified to **REMOVE** all Property Owners within the POA of the Shores subdivision.
