### **SOAH ORDER NO. 1** FILING DESCRIPTION; NOTICE OF PREHEARING CONFERENCE; AND ADMITTING INTERVENOR

# I. FILING DESCRIPTION

On April 12, 2016, the City of Celina (City) filed a Notice of Intent to Provide Retail Water and Sewer Service to the 127.930-Acre Tract Decertified from Aqua Texas, Inc (Aqua Texas). In the filing, the City notified the Public Utility Commission of Texas (Commission) that it seeks to provide water and sewer service to an area decertificated by the Commission in Docket No. 45329 from Aqua Texas as requested by CADG Sutton Fields II, LLC (Sutton Fields II).

The Commission has jurisdiction over this proceeding pursuant to Texas Water Code Chapter 13.<sup>1</sup> The Commission referred this case to the State Office of Administrative Hearings (SOAH) on July 7, 2016, requesting the assignment of an Administrative Law Judge (ALJ) to conduct a hearing and issue a proposal for decision (PFD), if necessary. SOAH has jurisdiction over matters relating to the conduct of the hearing in these proceedings pursuant to Texas Government Code § 2003.049. In its referral order, the Commission stated it will consider and possibly adopt a preliminary order in the July 20, 2016, open meeting.

#### **II. NOTICE OF PREHEARING CONFERENCE**
