Each of these persons filing a motion to intervene presented a justiciable interest in the outcome of this proceeding. No objections were raised against the above-referenced motions. Accordingly, these motions to intervene are granted.

For service of pleadings, a copy of the service list in this proceeding is attached to this order. In addition, the service list in this proceeding is available from the Public Utility Commission of Texas (Commission) by calling (512) 936-7169 and requesting a copy of the service list in Docket No. 45866. In accordance with 16 Tex. Admin. Code § 22.74 any document or pleading regarding this proceeding shall be filed with the Commission's Filing Clerk and served on all parties in the form required by 16 TAC § 22.71.

II. Withdrawal of Intervention

Order No. 5 issued on May 27, 2016 granted Mark LaRue and Ellen LaRue's requests to intervene. On June 15, 2016, the LaRue's filed a motion to withdraw their request for intervention. This Order grants the motion of Mark LaRue and Ellen LaRue to withdraw intervention. Their names are removed from the service list.


III. Motion for Good Cause Exception

On June 16, 2016, LCRA Transmission Services Corporation filed a motion for good cause exception and motion to suspend traditional service. LCRA TSC requests an extension until June 22, 2016, to respond to any motion to intervene filed after June 6, 2016. LCRA TSC is granted an extension until June 22, 2016 to respond to any motion to intervene, however, the extension is applicable only to motions to intervene filed after June 8, 2016.

LCRA TSC also requests to suspend traditional service rules in this case to allow for service via the Commission's Interchange. The Commission defers to the SOAH Administrative Law Judge for a ruling on the motion to suspend traditional service in this case.
