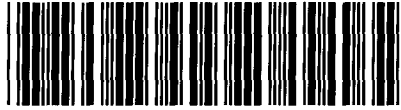

I, Joel Rogers, filed my Statement of Position under Item 1135 filed 9/7/2016.

I am listed on **SOAH 8** dated 10/20/2016 under Attachment A "SOAH ORDER NO. 8 – ATTACHMENT A – LIST OF PARTIES WHO FILED SOPS AND/OR TESTIMONY" on page 10 of 43.

Page one of this doc states "Attached to this order are two spreadsheets showing parties who are **still participating in the hearing and those who are dismissed.**"<sup>1</sup> Sub-comment "1" at bottom of page states "Attachments A and B, respectively". This should mean that I am participating in the hearing since I am listed in Attachment A not B.

**However, I am also listed on page 40 of 42 under Attachment C of SOAH 8 with NO explanation at all of what this means.** On page 24 of 43 of SOAH 8 the title to Attachment C is, "SOAH ORDER NO. 8 ATTACHMENT C ORDER NO. 6 SOAH LISTS MARKED WITH REVISIONS BY LCRA". I looked up Item 1303 being SOAH Order No. 6 and I am NOT listed as being dismissed but listed under Attachment B as "Intervenors Who Filed Statements of Position..". **WHAT REVISIONS ARE LCRA MAKING TO ME?**

More of comment 1 states at the bottom of page 1 of SOAH 8, "LCRA's correction lists are also attached to this order as Attachment C." As stated, I am listed under Attachment C. **WHAT CORRECTIONS ARE LCRA MAKING THAT APPLIES TO ME? Please explain if applicable.** I am not aware of any "corrections" or "revisions" that have been sent me.


