COMMISSION STAFF'S RESPONSE TO MOTIONS FOR REHEARING

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Response to Burleson Ranch and Lagmanson (Burleson Ranch) and the City of Cedar Park's (Cedar Park) motions for rehearing. In support thereof, Staff shows the following:

I. Introduction

On August 22, 2017, Burleson Ranch and Cedar Park filed motions for rehearing in response to the Commission's July 28, 2017, Order on Rehearing.¹ Pursuant to Tex. Gov't Code Ann. § 2001.146(b) (West 2016), Staff must file its reply not later than the 40th day after the date the Order on Rehearing was signed, which is September 6, 2017. Therefore, this reply is timely filed.

II. Reply

Both Burleson Ranch and Cedar Park's motions should be denied. Both motions, for the most part, assert the same points of error as the parties' previous motions for rehearing filed on July 3, 2017. Staff will not duplicate its response from its earlier filing but rather incorporates its responses from its July 17, 2017 filing.

Staff recommends the Commission deny Cedar Park and Burleson's motions for rehearing.




