**MOTION FOR CONTINUANCE**

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

COMES NOW, Complainants ADC West Ridge, L.P. and Center for Housing Resources, Inc. and file this Motion for Continuance pursuant to 16 Tex. Admin. Code § 155.307 and request a 45-day continuance to all remaining deadlines in this proceeding.

This is the first request for a continuance by either party in this proceeding. The City of Frisco has scheduled depositions of potential fact witnesses on January 5, 11, and 12, 2017, as well as depositions of Complainants' expert witnesses January 4 and 9, 2017. In addition, the parties agreed to supplement their discovery responses as ordered by the Administrative Law Judges in Order No. 7 no later than January 7, 2017. Complainants' prefiled testimony is currently due by January 13, 2017. Complainants' requested 45-day extension will allow Complainants sufficient time to review the additional discovery produced by the City of Frisco and determine whether additional depositions of Frisco's expert witnesses are appropriate before completing Complainants' prefiled testimony.

Complainants' conferred with the other parties to this proceeding. PUC Staff is not opposed to the request. Counsel for the City of Frisco indicated that Frisco would likely be opposed, but that he would confirm with his client and would notify Complainants upon

obtaining confirmation. As of the time of this filing, Complainants have yet to hear from Frisco's counsel and assume that Frisco is opposed to the motion.

If this motion is granted, the parties will confer and submit an agreed procedural schedule, along with three proposed hearing dates as required by 16 Tex. Admin. Code § 155.307.
