#### JOINT PROPOSED PROCEDURAL SCHEDULE

COMES NOW the Commission Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this response to SOAH Order No. 12 jointly with ADC West Ridge, L.P., the Center for Housing Resources, Inc, and the City of Frisco (jointly, the parties). The parties request that the below agreed-upon proposed procedural schedule be adopted. In support thereof, Staff shows the following:

#### I. BACKGROUND

SOAH Order No. 12, issued on March 16, 2017, ordered the parties to confer and propose a procedural schedule by March 21, 2017. Therefore, this pleading is timely filed.

#### II. PROPOSED PROCEDURAL SCHEDULE

The parties note their understanding that the following intermediate deadlines also apply. Pursuant to 16 Tex. Admin. Code § 22.78(a) (TAC), all responsive objections are due within five working days after receipt of the pleading objected to and responses to objections are due within five working days of receipt of the objection. Pursuant to 16 TAC § 22.144(c)(1), written responses to discovery must be filed within 20 days after receipt of the discovery request, unless otherwise agreed.

#### III. CONCLUSION

The parties respectfully request that the above proposed procedural schedule be adopted.
