SOAH ORDER NO. 14 RESETTING PROCEDURAL SCHEDULE

The schedule in this case was previously continued, as requested by the parties. SOAH Order No. 12 ordered the parties to propose a new schedule by March 21, 2017. On that day, the Staff of the Public Utility Commission of Texas (PUC) filed a joint proposed schedule to which all parties have agreed.

The schedule proposed by the parties is approved and is set out below:

06/14/17	Deadline by which depositions must be conducted.
07/14/17	Deadline to file discovery responses to requests that relate solely to the issue of annexation of the subject property by the City of Frisco (Frisco).
07/14/17	Direct testimony of ADC West Ridge, L.P.; and the Center for Housing Resources, Inc. (collectively, "Complainants).
07/28/17 .	Deadline to serve discovery on Complainants' direct testimony.
08/11/17	Frisco's direct testimony.
08/25/17	Deadline to serve discovery on Frisco's direct testimony.
09/08/17	Staff's direct testimony.
09/22/17	Deadline to serve discovery on Staff's direct testimony.
09/22/17.	All parties' rebuttal testimony.
09/29/17	Deadline to serve discovery on any parties' rebuttal testimony.
10/13/17	Deadline to file discovery responses regarding rebuttal testimony.
10/19/17	Prehearing conference (teleconference).
10/24-26/17	Hearing on the merits.

The prehearing conference will be held at 10:00 a.m. on October 19, 2017, when the parties will be called at their telephone numbers of record. The hearing on the merits will convene at 9:00 a.m., October 24, 2017, at the William P. Clements Office Building, Fourth Floor, 300 West 15th Street, Austin, Texas. Unless the Parties are notified otherwise, the hearing on the merits will continue each workday until it has concluded.

For any proceeding set to last longer than one day, a court reporter is generally required. 1 TAC § 155.423(b). The parties estimate that the hearing on the merits will last longer than one day. Complainants and Frisco shall jointly arrange and pay for a court reporter to record and transcribe the hearing on the merits and deliver the original transcript to the judges and Staff. The parties are responsible for paying the court reporter for their own copies of the transcript.
