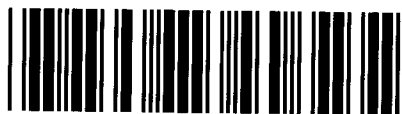

**ORDER NO. 2
DEEMING APPLICATION ADMINISTRATIVELY COMPLETE;
ADDRESSING NOTICE AND
ESTABLISHING PROCEDURAL SCHEDULE**

This Order addresses Commission Staff's recommendation on the sufficiency of the application of Riviera Water Systems, Inc. and Riviera Water Control and Improvement District for the sale and transfer or merger of facilities and certificate of convenience and necessity (CCN) rights in Kleberg County. Riviera CID seeks to acquire all of RWSI's facilities and certificated service area under water CCN No. 10924.

I. Administrative Completeness

On May 20, 2016, Commission Staff recommended the application be found sufficient and complete. Consistent with Commission Staff's recommendation, the application is deemed administratively complete.

II. Notice

Commission Staff recommended that applicants be required to provide notice consistent with Commission Staff's May 20, 2016 pleading and as specified in the memorandum of Janie Kohl, Gary Horton, and Elisabeth English of the Commission's Water Utility Regulation Division. Commission Staff also recommended that applicants be required to submit signed affidavits indicating that notice was given, along with a copy of the actual notices issued, within 30 days of the date of notice and last publication date.

Consistent with Commission Staff's recommendation, applicants shall provide notice consistent with Commission Staff's May 20, 2016 pleading and memorandum, and using the

attached forms. Additionally, applicants shall file affidavits evidencing proof of notice by the deadline set forth below.

III. Procedural Schedule

Commission Staff proposed a procedural schedule for continued processing of this docket. The following procedural schedule shall apply:
