COMMISSION STAFF'S RECOMMENDATION REGARDING SUFFICIENCY OF NOTICCE AND PROPOSED PROCEDURAL SCHEDULE

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Response to Order No. 2 and Recommendation Regarding Sufficiency of Notice and Proposed Procedural Schedule.

I. Background

On April 20, 2016, Riviera Water Systems, Inc. (RWSI) and Riviera Water Control and Improvement District (Riviera Water CID) (collectively, Applicants) filed an application for approval of a sale, transfer, or merger of facilities and certificate of convenience and necessity (CCN) rights in Kleberg County. Riviera CID seeks to acquire all of RWSI's facilities and certificated service area under water CCN No. 10924.

On May 24, 2016, the Administrative Law Judge (ALJ) issued Order No. 2 requiring Staff to file a recommendation on sufficiency of notice and an additional procedural schedule for the remainder of the proceeding by June 28, 2016. Therefore, this Response is timely filed.

II. Recommendation on Sufficiency of Notice

On June 20, 2016, the Applicants filed proof of notice of the application as directed by Staff. Staff reviewed the affidavits of notice and the individual notice issued with the accompanying map and recommends that notice is sufficient.

III. Proposed Procedural Schedule

Staff recommends the following procedural schedule:

| Expiration of 120-day deadline for Commission to approve the proposed sale or request a hearing pursuant to 16 TAC § 24.109(e). | October 13, 2016 |

III. Conclusion

Staff respectfully requests that the ALJ issue an order consistent with this Response.

¹ Pursuant to 16 TAC § 24.106(a)(3), the intervention deadline is 30 days after the mailing or publication of notice, whichever occurs later. Notice was mailed on June 15, 2016. Therefore, 30 days after June 15, 2016 is July 15, 2016.
