**UNOPPOSED REQUEST FOR EXTENSION OF TIME TO FILE PROOF OF NOTICE  
PURSUANT TO ORDER NO. 2**

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

COMES NOW, the City of Sanger, Texas, and Bolivar Water Supply Corporation (“Applicants”) and file this Request for Extension of Time, and in support thereof would respectfully show as follows:

Order No. 2 was executed on May 25, 2016, and set the deadline for Applicants to submit affidavits of notice, including a copy of the individual notice issued with the accompanying map, and the published notice as June 29, 2016. Applicants have not yet been able to publish the notice for the two-week publication. In part due to the upcoming holiday, Applicants request a one-month extension to the deadline to submit proof of notice from June 29, 2016 to July 27, 2016, which will insure that Applicants have sufficient time to have the notice published for two consecutive weeks. Commission Staff and Intervenor Sanger Holdings, LLC are unopposed to this request.


Applicants recommend the following procedural schedule if the requested extension is granted:

Deadline for Commission Staff to file an updated procedural schedule	August 3, 2016


