**ORDER NO. 4**  
**FINDING NOTICE SUFFICIENT AND ADOPTING PROCEDURAL SCHEDULE**

This Order addresses Commission Staff's July 28, 2016 recommendation that the City of Sanger has provided proper notice and Staff's proposed procedural schedule. Sanger filed affidavits of notice on July 26, 2016, along with a copy of the notices sent, and an affidavit verifying publication of notice. According to the affidavits, notice was mailed to neighboring utilities, landowners, and affected parties on July 7, 2016. In addition, notice was published in *Denton Record-Chronicle* on July 7 and July 14, 2016.

Consistent with Commission Staff's recommendation, applicants have provided proper and sufficient notice. A 30 day protest period follows the later of mailed or published notice.<sup>1</sup> In this instance, the 30-day period began on July 14, 2016, and will end on August 15, 2016.<sup>2</sup> The following schedule shall apply.


