**ORDER NO. 2  
DEEMING APPLICATION ADMINISTRATIVELY COMPLETE,  
ADDRESSING NOTICE; AND ESTABLISHING PROCEDURAL SCHEDULE**

This Order addresses Commission Staff's recommendation regarding administrative completeness of this application and proposed procedural schedule. Commission Staff stated that it interpreted this application as requesting two types of relief; first an amendment to the City of Sanger's water certificate of convenience and necessity (CCN) to include two tracts of land and second, an amendment to Bolivar Water Supply Corporation's CCN to remove the same two tracks. Commission Staff reviewed the application and notice with this relief in mind and recommended that the application be deemed administratively complete and that applicants be required to provide notice and submit signed affidavits indicating that notice was given, along with a copy of the actual notices issued, within 30 days of the date of notice and last publication date.

Consistent with Commission Staff's recommendation, the application is deemed sufficient and administratively complete. Additionally, applicants shall provide notice consistent with Commission Staff's May 23, 2016 pleading and as specified the attached memorandum of Andrew Novak and Kristy Nguyen of the Commission's Water Utility Regulation Division, using the forms attached to the Commission Staff memorandum. Applicants shall file affidavits evidencing proof of notice by the deadline set forth below.

The procedural schedule proposed by Commission Staff is adopted. Staff shall propose an additional procedural and/or make a supplemental recommendation upon completion of notice.
