SOAH ORDER NO. 3 ADOPTING PROPOSED PROCEDURAL SCHEDULE AND GRANTING REQUEST TO WAIVE THE DEADLINE

On June 3, 2016, Southwestern Public Service Company filed an Agreed Motion to Waive the Prehearing Conference and Unopposed Motion to Adopt Proposed Procedural Schedule and Waive the Deadline.

The prehearing conference set for June 7, 2016, is canceled.

For a utility in an area for which customer choice is not offered, the presiding officer must set a procedural schedule that will enable the Commission to issue a final order in the proceeding prior to the January 1 effective date of the utility's Energy Efficiency Cost Recovery Factor ("EECRF"), except for good cause.¹ However, 16 Texas Administrative Code (TAC) § 25.181(f)(9)(E) provides that if a hearing is requested within 30 days of the filing of the application, the presiding officer must set a procedural schedule that will enable the Commission to issue a final order in the proceeding within 180 days after the application was filed, which for SPS would be October 29, 2016.

The parties have conferred and agreed to the following proposed procedural schedule that would enable the Commission to issue a final order in the proceeding prior to the January 1, 2017 deadline in 16 TAC § 25.181(f)(9)(A). However, the proposed schedule would likely not enable the Commission to issue a final order by the 180-day deadline in 16 TAC § 25.181(f)(9)(E). The parties requested an order waiving the 180-day deadline in 16 TAC § 25.181(f)(9)(E) and adopting a

procedural schedule. Staff did not oppose the adoption of this schedule or the waiver of the 180-day deadline. The request is granted. The 180-day deadline in 16 TAC § 25.181(f)(9)(e) is waived.
