OLD TAMINA WATER SUPPLY CORPORATION'S RESPONSE TO ORDER NO. 24 AND REQUEST FOR EXTENSION

NOW COMES Old Tamina Water Supply Corporation and hereby files this Response to Order No. 24 and Request for Extension.

I. Background

On May 9, 2019, the Commission granted the request for rehearing filed by Old Tamina Water Supply Corporation ("Old Tamina"). The Commission also rescinded the Notice of Approval issued on March 19, 2019 and remanded this proceeding to Docket Management for further processing. Further, the Commission directed Old Tamina to amend its application and submit evidence supporting the amended application.

On July 22, 2019, the Administrative Law Judge issued Order No. 24 requiring that Old Tamina submit an amended application with appropriate supporting evidence on or before August 5, 2019. Therefore, this Response is timely filed.

II. Response and Request for Extension

Old Tamina requested rehearing because the wholesale wastewater treatment service provider previously identified in Old Tamina's application was no longer willing to provide service. Old Tamina has since made diligent efforts to secure a replacement provider.

On or about July 25, 2019, the board of directors of Chateau Woods Municipal Utility

District ("Chateau Woods") voted to provide wholesale wastewater treatment services to Old

Tamina. Chateau Woods has been the wholesale potable water supplier for Old Tamina for many

years and is now willing to add wastewater treatment. Chateau Woods is currently drafting the

agreement for services and Old Tamina expects to receive it within the coming weeks. Once

Chateau Woods and Tamina have agreed on the final language of the agreement, the agreement

must be submitted to USDA for approval. Old Tamina must obtain USDA approval of the

agreement prior to executing it because Old Tamina's sewer project will be financed with a \$2.2

million loan and grant package previously approved by USDA. After USDA approves the

agreement, Chateau Woods and Old Tamina will then execute it.

Old Tamina respectfully requests an extension of the deadline to amend its application until

October 31, 2019, so that it may complete drafting and negotiation of the wholesale wastewater

treatment service agreement with Chateau Woods, submit the agreement to USDA for review and

approval, and then execute the final agreement with Chateau Woods.

WHEREFORE, PREMISES CONSIDERED, Old Tamina respectfully requests that this

Request for Extension be granted. Old Tamina respectfully requests the entry of an order consistent

with this request.
