# OLD TAMINA WATER SUPPLY CORPORATION'S STATUS REPORT

**NOW COMES** Old Tamina Water Supply Corporation and hereby files this Status Report as required by Order No. 30 Requesting Status Update.

#### I. Background

On May 9, 2019, the Commission granted the request for rehearing filed by Old Tamina Water Supply Corporation ("Old Tamina"). After the rehearing, the Commission rescinded the Notice of Approval issued on March 19, 2019 and remanded this proceeding to Docket Management for further processing. Further, the Commission directed Old Tamina to amend its application and submit evidence supporting the amended application.

On August 21, 2020, Commission Staff filed a status report concerning this docket. Commission Staff indicated that Old Tamina was pursuing the option of acquiring and operating its own onsite package treatment plant using previously approved United States Department of Agriculture (USDA) loan and grant funding. Further, Commission Staff indicated that Old Tamina was in the process of obtaining USDA approval for its current plan and was working toward obtaining necessary permits from the Texas Commissions on Environmental Quality (TCEQ). Commission Staff recommended that Old Tamina be required to file updates regarding the status of its application every 90 days, beginning on October 9, 2020.

On August 28, 2020, the Administrative Law Judge (ALJ) issued Order No. 28 Requiring Status Reports. Per the Order, Old Tamina was required to file a status report regarding the status of its application on or before October 9, 2020, and every 90 days thereafter until otherwise ordered.

On October 8, 2020, Old Tamina filed a Status Report.

On May 27, 2021, the ALJ issued Order No. 29 Requesting Status Update requiring that Old Tamina file a status report on or before June 4, 2021.

On June 3, 2021, Old Tamina filed a Status Report. The filing had Tracking Number TGJUUPRQ and was emailed to Central Records On June 3, 2021 at 7:15 p.m. However, the Status Report contained a typographical error in its Certificate of Service that incorrectly stated the document was served on June 3, 2020, when it was actually served on June 3, 2021. This filing does not currently appear on the online PUC Interchange Filing website. In this filing, Old Tamina reported that it was continuing to work with USDA and TCEQ to secure their approval for Old Tamina's project.

On September 28, 2021, the ALJ issued Order No. 30 Requesting Status Update requiring Old Tamina to file a Status Update on or before October 28, 2021 or submit a motion to withdraw its application.

## II. Status Report

Old Tamina has continued to work on its plan to acquire and operate its own onsite package sewage treatment plant. The 2.2 million dollar USDA grant and loan package remains obligated for financing of Old Tamina's sewer project. Old Tamina has continued the process of completing its application for a wastewater treatment plant permit with TCEQ.

While continuing to work with the USDA and TCEQ, Old Tamina has simultaneously

engaged in ongoing communication with state and local governmental authorities regarding

obtaining assistance in completing its sewer project. A meeting is scheduled to take place on

November 16, 2021, including Montgomery County, the City of Shenandoah, and Old Tamina, to

discuss the potential use of grant money secured by Old Tamina's State Representative to pay for

Old Tamina's sewer system project.

WHEREFORE, PREMISES CONSIDERED, Old Tamina respectfully submits this

Status Report as Required by Order No. 30.
