**ORDER NO. 3
DEEMING NOTICE SUFFICIENT AND
ESTABLISHING PROCEDURAL SCHEDULE**

This Order addresses Commission Staff's August 11, 2016 recommendation that the notice of this application provided Crystal Springs Water Company, Inc. was sufficient and Commission Staff's proposed procedural schedule for continued processing. Commission Staff indicated that on August 1, 2016, Crystal Springs submitted affidavits of notice, copies of mailed notice, and copies of published notice. Commission Staff stated that Crystal Springs mailed notice on July 12, 2016 and published notice on July 15, 2016 and July 22, 2016.


Consistent with Commission Staff's recommendation, the notice provided by Crystal Springs is sufficient. Additionally, Commission Staff's procedural schedule is adopted as proposed:

Deadline for Commission Staff to provide final maps, certificates, and tariffs (if applicable), to Crystal Springs for review and consent	October 22, 2016
Deadline for Crystal Springs to file signed consent forms with the Commission	November 4, 2016
If no hearing is requested, deadline for Commission Staff to file a final recommendation on the application	November 14, 2016
If no hearing is requested deadline for parties to file joint proposed findings of fact, conclusions of law	November 18, 2016

¹ Pursuant to 16 Tex. Admin. Code § 24.106(a)(3) (TAC), the intervention deadline is 30 days after the mailing or publication of notice, whichever occurs later. Notice was mailed on July 12, and published on July 15 and July 22, 2016. Thirty days after July 22, 2016 (the latest date) is a Sunday, August 21, 2016. The next business day is August 22, 2016.
