#### FORT GRIFFIN SPECIAL UTILITY DISTRICT'S STATUS INQUIRY

COMES NOW, Fort Griffin Special Utility District ("District") and files this Status Inquiry.

On November 2, 2010, the undersigned attorney submitted a Notice of Dissolution of Shackelford Water Supply Corporation and Transfer of CCN No. 11637 to Fort Griffin Special Utility District, to the Texas Commission on Environmental Quality ("TCEQ") (see <u>Attachment</u> "<u>A</u>") with the request that the TCEQ reissue the CCN in the name of Fort Griffin Special Utility District. Subsequently, the Notice of Dissolution was transferred to the Public Utility Commission ("PUC") and assigned PUC Control No. 46032 around June 6, 2016.

The District has not received any communication from the TCEQ or PUC Staff confirming that the transfer of the CCN was completed. The PUC Mapping Database shows the CCN area to still be in the name of Shackelford Water Supply Corporation.

As background, Fort Griffin Special Utility District was created by an act of the Texas Legislature House Bill 1573, which was effective September 1, 2007 (the "Act"). As noted on the attached documentation, the creation of the District was confirmed by an election held on May 16, 2009 and thereafter the assets of the Shackelford Water Supply Corporation were transferred to the District and the Water Supply Corporation was terminated and dissolved. Following dissolution, by letter dated November 2, 2010 the request was filed with the TCEQ to transfer the CCN. The operative provision of the Act (Sec. 7210.023 (e)) regarding transfer of the CCN stated:

On receipt of notice under Subsection (d) [the notice of dissolution], the Texas Commission on Environmental Quality shall note in its records that Certificate of Convenience and Necessity No. 11637 is held by the district and <u>shall reissue the certificate in the name of</u> the district without further application, notice, or hearing. A person does not have a right to protest or to request an administrative review of the transfer prescribed by this section.

The District is in the process of obtaining new financing for system improvements, and it is not time critical that the PUC records be updated to correctly reflect that CCN No. 11637 is held by Fort Griffin Special Utility District.

Fort Griffin Special Utility District makes this filing to determine whether the CCN has been transferred to the District, and the Mapping Database has been updated, or if not, what additional information is needed.



Dear Ms. Harbour:

The purpose of this letter is to provide notice that the Shackelford Water Supply Corporation (the "Corporation") has been dissolved and that, pursuant to Chapter 7210, Special District Local Laws Code (the "Act"), CCN No. 11637 is now held by the Fort Griffin Special Utility District (the "District"). We hereby respectfully request that, in compliance with the Act, the Texas Commission on Environmental Quality note in its records that CCN No. 11637 is now held by the District and that the Commission reissue the CCN in the District's name.

As you may know, the Texas Legislature during the 80th Session (2007) adopted the Act, which created the District as a special utility district with the powers and authority of such districts under Chapters 49 and 65 of the Texas Water Code. Thereafter, the creation of the District was confirmed by an election held within the District on May 16, 2009. The notice of election, order of election, and order canvassing the results are attached as <u>Attachment "A"</u>. For reference, a map of the Corporation's CCN area is attached as <u>Attachment "B"</u>.

As to the transfer of the CCN to the District, the Act states as follows:

(c) On dissolution of the Shackelford Water Supply Corporation, Certificate of Convenience and Necessity No. 11637 is considered to be held by the district.

(d) The board of directors of the Shackelford Water Supply Corporation shall notify the Texas Commission on Environmental Quality of the dissolution of the corporation and of the transfer of Certificate of Convenience and Necessity No. 11637 to the district.






