SOAH ORDER NO. 6
ADMITTING EVIDENCE, REMANDING CASE, AND
DISMISSAL OF SOAH DOCKET

On April 26, 2017, staff (Staff) of the Public Utility Commission of Texas (Commission) and applicant Nitsch & Son Utility Company, Inc. (Applicant) filed a Joint Motion to Admit Evidence and Remand (Joint Motion). The Joint Motion states that the parties have entered into a stipulation and that no disputed issues remain, requests that evidence be admitted and the case be dismissed from the docket of the State Office of Administrative Hearings and remanded to the Commission. The Joint Motion is **GRANTED**.
