ORDER NO. 4 REQUIRING ADDITIONAL INFORMATION FROM APPLICANT; ESTABLISHING DEADLINES

This Order addresses Commission Staff's November 4, 2016 recommendation regarding administrative completeness of the revised application. Commission Staff has completed the review of the revised application and determined that it satisfactorily addressed the deficiencies previously identified in Commission Staff's first recommendation on administrative completeness. However, the revised application does not contain an affidavit affirming the contents of the application as required by Commission rules and corrected notice has not yet been issued. Commission Staff recommended the applicant (1) provide corrected notice, as attached in Commission Staff's November 4, 2016 recommendation, to affected customers at least 35 days before the effective date of the proposed change, (2) file a copy of the notice and affidavit of notice with the Commission and provide a copy of the notice to the appropriate offices of each municipality affected by the proposed rate change and to the Office of Public Utility Counsel, and (3) file a copy of the attached affidavit attesting to the correctness of the application in accordance with the instructions for the Class B rate application, page 7, Attachments required for sufficiency.

No later than December 5, 2016, the applicant shall (1) provide corrected notice, as attached in Commission Staff's November 4, 2016 recommendation, to affected customers at least 35 days before the effective date of the proposed change, (2) file a copy of the notice and affidavit of notice with the Commission and provide a copy of the notice to the appropriate offices of each municipality affected by the proposed rate change and to the Office of Public Utility Counsel, and (3) file a copy of the attached affidavit attesting to the correctness of the application in accordance with the instructions for the Class B rate application, page 7, Attachments required for sufficiency.

Commission Staff's proposed procedural schedule is approved, as follows:

Deadline for L&M to file proof of notice and application affidavit	December 5, 2016
Deadline for Staff to file a recommendation on sufficiency of notice and propose an additional procedural schedule	Within 10 days of L&M filing proof of completed notice
Deadline to Intervene	30 days after notice is issued
