COMMISSION STAFF'S MOTION TO RESCHEDULE PREHEARING CONFERENCE

COMES NOW the Commission Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Motion.

On June 28, 2016, Shore-Tech, Inc. d/b/a L&M Water Development Company (Shore-Tech) filed an application with the Commission for a rate/tariff change pursuant to 16 Tex. Admin. Code §§ 24.21–24.36 (TAC). Shore-Tech seeks a rate increase for its public water system (PWS) #1010145 in Galveston County, Texas. On April 28, 2017, SOAH Order No. 1 was entered, scheduling a prehearing conference in this proceeding for May 8, 2017.

Due to the unavailability of Staff's counsel, Staff respectfully requests that the prehearing conference be rescheduled for any day during the week of May 15–19, 2017. In addition, Staff and Shore-Tech have engaged in settlement discussions, and rescheduling the prehearing conference would permit an opportunity for further discussions.

Staff has conferred with Shore-Tech, which indicated it is not opposed to this motion.




