### **COMMISSION STAFF'S FINAL RECOMMENDATION**

**COMES NOW** the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files) this Recommendation on Sufficiency of Closing Documents. In support thereof, Staff shows the following:

#### I. BACKGROUND

On June 29, 2016, Bethany Hearne Water Supply Company (Bethany Hearne WSC) and the City of Hearne (collectively Applicants) filed an application for sale, transfer, or merger (STM) of facilities and certificate of convenience and necessity rights in Robertson County. Specifically, the City of Hearne seeks approval to acquire a portion of the water system assets of Bethany Hearne WSC held under water Certificate of Convenience and Necessity (CCN) No. 10330.

Order No. 4, issued October 18, 2016, approved the sale/transfer to proceed with closing. Applicants filed closing documentation on May 15, 2017 and supplemental documentation on June 8, 2017. Order No. 6 found the closing documents sufficient and gave Staff a deadline of July 17, 2017 to file a final recommendation. This pleading is therefore timely filed.

## **II. FINAL RECOMMENDATION**

No requests for hearing were filed, and the Application meets the requirements of 16 Tex. Admin. Code §§ 24.109, as supported by the attached memorandum of Debbie Reyes Tamayo of the Water Utilities Division. Therefore, Staff recommends that the Application be approved. The consented CCN and map are also attached. Staff further recommends that the City of Hearne file certified copies of the CCN map along with a written description of the CCN service area in the appropriate county clerk's office pursuant to TWC §§ 13.257 (r) and (s).

## **III. CONCLUSION**

Staff respectfully requests that the ALJ issue an order reflecting the above request.

On June 29, 2016, City of Hearne (Hearne or Purchaser), Certificate of Convenience and Necessity (CCN) No. 10344 and Bethany Hearne Water Supply Company (Bethany Hearne or Seller), CCN No. 10330, (collectively, Applicants) filed an application for approval of a sale, transfer, or merger (STM) of facilities and certificate rights in Robertson County, Texas. The application was filed under the provisions in Texas Water Code §§ 13.241, 13.246, 13:301 (TWC) and 16 Tex. Admin. Code §§ 24.102 and 24.109 (TAC). Specifically, Hearne seeks approval to acquire the water system assets, customers and service area of Bethany Hearne, to cancel Certificate of Convenience and Necessity (CCN) No. 10330 and to incorporate the service area into Hearne's CCN No. 10344.

Approving this application and transferring the requested service areas, facilities and customers from the Bethany Hearne Water Supply Company (Seller) to the City of Hearne (Purchaser) is necessary for the service, accommodation, convenience and safety of the public.

Attached is the map and certificate that, if adopted, would effectuate the requested transaction.

The Applicants consented to the attached map and certificate on June 28, 2017.
