



COMMISSION STAFF'S RESPONSE TO THE REQUEST TO STAY

Commission Staff (Staff) of the Public Utility Commission (Commission) of Texas files its Response. In support of its Response, Staff states the following:

I. Background

The City of Midlothian notified the Commission of its intent to provide retail water service to an approximately 97.7-acre tract of land that was decertified in Docket No. 44394.¹ The decertified area was in Mountain Peak Special Utility District's certificated service area. With regard to this type of proceeding, the Texas Water Code requires that the Commission determine whether any property has been rendered useless or valueless.²

Mountain Peak Special Utility District now requests that the Administrative Law Judge's stay this proceeding. The basis for this request is that Mountain Peak Special Utility District intends to appeal the Commission's order in Docket No. 44394 to the Third Court of Appeals. Mountain Peak Special Utility District asserts that this proceeding should be stayed in order to preserve resources.

II. Staff's Response

Staff opposes the Mountain Peak Special Utility District's request to stay this proceeding. In deciding to appeal the Commission's order in Docket No. 44394, Mountain Peak Special Utility District has created the very reason it is requesting a stay: the necessity to incur additional time and resources to litigate the appeal before the Third Court of Appeals. This result from Mountain Peak Special Utility District's litigation decision is not a sufficient reason to stay this proceeding.

Additionally, there is no timeframe by which the Third Court of Appeals will decide Mountain Peak Special Utility District's appeal, potentially resulting in this proceeding being stayed indefinitely. Thus, Mountain Peak Special Utility District's request to stay this proceeding should be denied.

III. Conclusion

Mountain Peak Special Utility District's request to stay this proceeding should be denied because it has not presented sufficient reasons that justify a stay.
