# CITY OF MIDLOTHIAN'S NOTICE OF NON-AGREEMENT ON SINGLE APPRAISER

# TO THE PUBLIC UTILITY COMMISSION OF TEXAS:

On July 1, 2016, the City of Midlothian, Texas (Midlothian) and notified the Commission pursuant to Texas Water Code (TWC) § 13.254(d) & (e) and PUC Subst. Rule 24.113(h) & (i) of Midlothian's intent to provide retail water service to an approximately 97.7-acre tract of land (Decertified Property) which was decertified from Mountain Peak Special Utility District (Mountain Peak) water Certificate of Convenience and Necessity (CCN) No. 10908 in PUC Docket No. 44394. Midlothian hereby notifies the Commission that the parties have not reached agreement on a single appraiser. Midlothian understands that its appraisal is to be submitted to the Commission no later than 60 days after the date of its Notice of Intent to Serve was provided, i.e., on or before August 30, 2016.

THEREFORE, the City of Midlothian prays that the Commission take notice that Mountain Peak and Midlothian have been unable to agree on a single appraiser and that appropriate public notice of this Notice of Intent be published as required by Commission rules.
