## JOINT STATUS UPDATE

**COMES NOW** the Staff (Staff) of the Public Utility Commission of Texas (Commission). representing the public interest, on behalf of itself and the City of Midlothian (Midlothian), and files this Joint Status Update. In support thereof, Staff shows the following:

State Office of Administrative Hearings (SOAH) Order No. 10, issued February 13, 2017, abated this proceeding until the Commission issued a final order in Docket No. 45848. SOAH Order No. 10 ordered that within one week after the Commission order in Docket No. 45848 became final and appealable, the parties confer and file a pleading with three agreed dates for a prehearing conference to discuss a procedural schedule going forward in this docket. The Order on Rehearing in Docket No. 45848 became final and appealable on August 23, 2017.<sup>2</sup> Therefore, this status update is timely filed by August 30, 2017.

Staff has conferred with counsel for Midlothian, and is authorized to represent that the parties are available for a prehearing conference on the following dates:

> Monday, September 18, 2017 Tuesday, September 19, 2017 Monday, September 25, 2017

Staff has also conferred with counsel for Mountain Peak Special Utility District, which will not join in this status update due to the District's intention to withdraw as a party to this proceeding.
