**AGREED MOTION TO ABATE
PROCEDURAL SCHEDULE**

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

NOW COMES, Undine Development LLC ("Undine") and files this Agreed Motion to Abate the Procedural Schedule in the above-styled proceeding, and in support thereof shows the following:

All of the Parties in this proceeding are also parties to PUC Docket No. 46333; *Application of PK-RE Development Company, Inc. d/b/a Oak Shores Water System for Authority to Change Rates and Tariffs in Travis County* ("PK-RE Rate Case"). Parties in the PK-RE Rate Case are currently engaged in settlement discussions, which may affect the positions of parties and potentially resolve most, if not all, of the contested issues in this proceeding.

Therefore, Parties have all agreed that abating the procedural schedule for 30 days will allow for potential resolution of the issues in this proceeding. Parties ask that they be allowed to file a status report at the end of the 30 days with an update on the settlement discussions and/or a new proposed procedural schedule in the event that parties fail to reach an agreement in the PK-RE Rate Case such that this proceeding must still be litigated.

Counsel for Undine has also conferred with Public Utility Commission ("Commission") Staff in this docket, and is authorized to state that Commission Staff agrees with this Motion.

Accordingly, the Parties jointly request that the Administrative Law Judge enter an order consistent with the draft attached hereto as Exhibit A.




