AGREED MOTION TO CANCEL PROCEDURAL SCHEDULE

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

NOW COMES, Undine Development LLC ("Undine") and files this Agreed Motion to Cancel the Procedural Schedule. Counsel for Undine has conferred with Residents of Woods of Greenshores, Cynthia Smiley, Greenshores on Lake Austin Property Owners Association, Inc., Woods of Greenshores Property Owners Association, Inc., Public Utility Commission Staff, and PK-RE Development Company, Inc. d/b/a Greenshores Utility Services and d/b/a Oak Shores Water System ("PK-RE"), and is authorized to represent that all parties agree to cancel the procedural schedule established in SOAH Order No. 8.1

The parties have reached a settlement agreement that resolves all issues in this proceeding and in the docket concerning PK-RE's rate application.² Therefore, the parties ask that the Administrative Law Judge cancel the procedural schedule established in this docket and allow the parties to file the settlement agreement and all associated documents supporting the settlement by October 16, 2017. All parties agree with this Motion.
