COMMISSION STAFF'S REQUEST FOR EXTENSION

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Request for Extension. In support thereof, Staff shows the following:

I. BACKGROUND

On July 11, 2016, PK-RE Development Company, Inc. d/b/a Oak Shores Water System (PK-RE) and Undine Texas, LLC (Undine) (collectively, Applicants) filed an Application for Sale, Transfer, or Merger (STM).

On December 17, 2018, the Administrative Law Judge (ALJ) issued Order No. 8, finding the closing documents sufficient under 16 Texas Administrative Code (TAC) § 24.239(n) and establishing a revised procedural schedule. Due to pending matters regarding final maps, certificates, and tariffs, Staff respectfully requests an extension of the procedural schedule by one week to allow Undine sufficient time to file signed consent forms with the Commission. Staff is authorized to represent that Undine is unopposed to the extension.

II. PROCEDURAL SCHEDULE

In accordance with Staff's request for extension, Staff proposes the following supplemental procedural schedule:

Event	Date
Deadline for Applicant to file signed consent forms with the Commission	January 11, 2019
Deadline for parties to jointly file detailed, legally sufficient findings of fact and conclusions of law that meet the components of TWC § 13.246 and that supports the relief requested	January 23, 2019



III. CONCLUSION

Staff respectfully requests the entry of an order adopting the above proposed procedural schedule.
