DEEMING APPLICATION SUFFICIENT; ADDRESSING NOTICE AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses Commission Staff's recommendation on the sufficiency of the application filed by PK-RE Development Company, Inc. d/b/a Oak Shores Water System (Oak Shores) and Undine Development, LLC (Undine) for sale, transfer, or merger of facilities and certificate of convenience and necessity rights in Travis County.

I. Administrative Completeness

On August 10, 2016, Commission Staff recommended the application be found sufficient and complete. Consistent with Commission Staff's recommendation, the application is deemed administratively complete.

II. Notice

Commission Staff also recommended that Undine provide notice and submit signed affidavits indicating that notice was given, along with a copy of the actual notices issued. Consistent with Staff's recommendation, Undine shall provide notice as described in Commission Staff's August 10, 2016 filing and consistent with the criteria outlined in the attached memorandum of Sean Scaff and Komal Patel of the Commission's Water Utility Regulation Division, using the forms attached to the Commission Staff memorandum and including a map of the proposed service area. Undine shall file an affidavit evidencing proof of notice by the deadline set forth below.
