

ORDER NO. 5

FINDING APPLICATION SUFFICIENT, REQUIRING NOTICE, AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses Commission Staff's January 27, 2017 supplemental recommendation that the amended application of Vista Verde Water Systems, Inc. and Simply Aquatics, Inc. for the sale, transfer, or merger of facilities and certificate rights in Montgomery County should be deemed sufficient for further review. Commission Staff recommended that the applicants should be required to provide notice of the application, and proof of notice, in a manner that is consistent with Commission Staff's January 27, 2017 pleading and as specified in the attached memorandum of Patricia Garcia and Tracy Montes of the Commission's Water Utility Division, using the forms attached to the memorandum. Commission Staff proposed a procedural schedule for continued processing of this application.

Consistent with Commission Staff's recommendation, Las Playa and Simply Aquatics' amended application is sufficient and accepted for filing. Applicants shall provide notice of the application and proof of notice in the manner and form described in Commission Staff's January 27, 2017, recommendation and the attached memorandum, using the forms provided.
