COMMISSION STAFF'S RECOMMENDATION THAT APPLICATION BE FOUND ADMINISTRATIVELY COMPLETE

Comes now the staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this response to Order No. 1. In support thereof, Staff would show the following:

I. Background

On On July 21, 2016, SWWC Utilities, Inc. d/b/a Diamond Water Company (Diamond Water) and SWWC Utilities, Inc. d/b/a Water Services, Inc. (Water Services) filed an application for sale, transfer, or merger of facilities and certificate of convenience and necessity rights in Bandera, Comal, and Gillespie Counties. Specifically, Water Services seeks approval to acquire all of the water system assets of Diamond Water held under water Certificate of Convenience and Necessity (CCN) No. 12865.

On July 25, 2016, the Administrative Law Judge issued Order No. 1, requiring Staff to file on or before August 22, 2016 comments/recommendation regarding administrative completeness of the application, whether additional notice may be required, and propose a schedule for processing. Therefore, this pleading is timely filed.

II. Administrative Completeness

Staff has reviewed the application and, as supported by the attached memorandum from Emily Sears and Kristy Nguyen in the Commission's Water Utility Regulation Division, recommends that the application be found administratively complete and accepted for filing pursuant to 16 Tex. Admin. Code § 24.8 (TAC).

III. Notice

Staff has reviewed the proposed notice in the application and recommends that, consistent with the attached memorandum, the Applicants be directed to provide notice to the following:

- a) any districts, utilities, and cities within two (2) miles of the proposed area;
- b) the county judge of each county and each groundwater conservation district that is wholly or partly included in the proposed area to be certified;
- c) each city with an extraterritorial jurisdiction (ETJ) that is wholly or partly included in the proposed area to be certified; and
 - d) any customers transferred, or other affected parties in the requested area.

In addition, Staff recommends that Applicants be directed to provide notice to the following entities:

On July 21, 2016, SWWC Utilities, Inc. dba Water Services, Inc. (Purchaser) filed with the Public Utility Commission of Texas (Commission) an application to purchase facilities and transfer and cancel all of water Certificate of Convenience and Necessity (CCN) No. 12865 of SWWC Utilities, Inc. dba Diamond Water Company (Seller) (collectively, Applicants), in Bandera, Comal, and Gillespie Counties, Texas pursuant to Texas Water Code Ann. (TWC), §§ 13.301 and the 16 Tex. Admin Code (TAC) §§ 24.109 and 24.112.

Staff has reviewed the required application and mapping information and recommends that the application be deemed administratively complete and sufficient for filing. Staff further recommends the Applicant be ordered to do the following:

- 1) Provide notice to the following:
 - a) any districts, utilities, and cities within two (2) miles of the proposed area;
 - b) the county judge of each county and each groundwater conservation district that is wholly or partly included in the proposed area to be certified;
