**ORDER NO. 2
DEEMING APPLICATION SUFFICIENT; ADDRESSING NOTICE AND
ESTABLISHING PROCEDURAL SCHEDULE**

This Order addresses Commission Staff's recommendation on the sufficiency of the application filed by John Frias Waste Water Utility and Olmito Water Supply Corporation, Inc. (collectively, applicants) for sale, transfer, or merger of facilities and certificate of convenience and necessity rights in Cameron County.

I. Administrative Completeness

On August 22, 2016, Commission Staff recommended the application be found sufficient and complete. Consistent with Commission Staff's recommendation, the application is deemed administratively complete.

II. Notice

Commission Staff also recommended that applicants provide notice and submit signed affidavits indicating that notice was given, along with a copy of the actual notices issued, within 30 days of the date of notice. Consistent with Staff's recommendation, applicants shall provide notice as described in Commission Staff's August 22, 2016 filing consistent with the criteria outlined in the memorandum of Fred Bednarski, Jolie Mathis, and Gary Horton of the Commission's Water Utility Regulation Division, using the forms attached to the Commission Staff memorandum. Applicants shall file an affidavit evidencing proof of notice by the deadline set forth below.

III. Procedural Schedule

Commission Staff proposed a procedural schedule for continued processing of this docket. Accordingly, the following procedural schedule shall apply:

Deadline for applicants to file with the Commission a copy of the actual notice issued, the map issued with the individual mailed notice, and a signed affidavit indicating that notice was given	September 22, 2016
Deadline to Intervene or request a hearing	30 days after the mailing of notice
Deadline for Commission Staff to file a recommendation on sufficiency of notice and an additional procedure schedule for the remainder of the proceeding	October 3, 2016
