COMMISSION STAFF'S RECOMMENDATION FINDING APPLICATION ADMINISTRATIVELY COMPLETE

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Response to Order No. 2 and Recommendation Finding Application Administratively Complete. In support thereof, Staff shows the following:

I. Background

On July 26, 2016, The Commons Water Supply, Inc. (The Commons) filed a petition to decertify area from its water certificate of convenience (CCN) No. 12781 in Harris County. On September 23, 2016, The Commons filed a form 10362 petition to amend its water CCN and supplement its application.

On August 26, 2016, Order No. 2 was issued requiring Staff to file comments regarding administrative completeness of the application and propose a procedural schedule by October 10, 2016. Accordingly, this pleading is timely filed.

II. Comments and Recommendation on Administrative Sufficiency

Staff recommends restyling this docket as "Application of The Commons Water Supply, Inc. to Amend a Water Certificate of Convenience and Necessity in Harris County" to reflect the intent of the application and the subsequent filing of the PUC form 10362 petition by The Commons to amend its water CCN.

Review for administrative completeness of CCN applications is governed by 16 Tex. Admin. Code § 24.8 (TAC). Furthermore, 16 TAC § 24.105 provides the Commission's required contents of a CCN application, and 16 TAC § 24.106 provides the Commission's notice

requirements for CCN applications. As supported by the attached memorandum of Debbie Reyes Tamayo, Program Specialist and Gary Horton, GIS Specialist with the Water Utilities Division, Staff recommends the application be deemed administratively complete and sufficient for filing pursuant to 16 TAC §24.8. Staff also recommends the following:

- 1. The Applicant shall provide notice of the application to the following:
 - a) any districts, utilities, and cities within two (2) miles of the proposed area;
 - b) the county judge of each county and each groundwater conservation district that is wholly or partly included in the proposed area to be decertified;
 - c) each city with an extraterritorial jurisdiction (ETJ) that is wholly or partly included in the proposed area to be decertified;
 - d) publish notice once each week for two (2) consecutive weeks in a newspaper of general circulation in Harris County.
- 2. The Applicant shall provide notice of the application to the following:
 - Aqua Texas, Inc. (CCN 13203)
 - City of Houston
 - Coastal Water Authority
 - Gulf Coast Waste Disposal Authority
 - Harris County
 - Harris County FCD
 - Harris County MUD 415
 - Harris County 483
 - Harris County 518
 - Harris-Galveston Coastal Subsidence District
 - Luce Bayou PUD
 - Pine Bough PUD
 - Port of Houston Authority
- 3. The Applicant should include a copy of a map with the individual notices to customers, neighboring utilities, and other affected parties. The map should show only the proposed service area(s) with enough detail to accurately locate the proposed service area(s) in reference to verifiable man-made and/or natural landmarks such as roads, railroads, and rivers. It is the Applicant's burden to provide an accurate map delineating the proposed area with each individual notice. Information related to districts including addresses can be obtained bv the **Applicant** from TCEQ web site located http://www14.tceq.texas.gov/iwud/.

Staff further recommends that within 30 days of the Commission order, The Commons submit a copy of the actual notice issued, the map issued with the individual mailed notice, tear

sheets of the newspaper notice, and the signed affidavits (copies attached), indicating that the notice was given.

III. Proposed Procedural Schedule

Staff recommends the application be found administratively complete. Staff therefore proposes the following procedural schedule:

Deadline for The Commons to file with the Commission signed affidavits that the notice was given along with a copy of the notice sent to the affected parties and published in a newspaper of general circulation	November 29, 2016
Deadline for Staff to file a recommendation on sufficiency of notice	Within 10 days of Applicant filing proof of completed notice with the Commission
Deadline to intervene	30 days after notice is issued

IV. Conclusion

Staff respectfully requests that an order be issued consistent with this Recommendation.

On July 26, 2016, The Commons Water Supply, Inc. ("Applicant") filed a petition to decertify a portion of an area from its water Certificate of Convenience and Necessity (CCN) No. 12781 in Harris County pursuant to Texas Water Code Ann. (TWC), §§ 13.242 to 13.250 and the 16 Tex. Admin Code (TAC) §§ 24.101 to 24.107. On September 23, 2016, the Applicant filed a form 10362 petition to amend its water CCN and supplement its application.
