SOAH ORDER NO. 1 GRANTING MOTION TO SEVER RATE CASE EXPENSES AND ESTABLISHING DOCKET FOR RATE CASE EXPENSE PHASE

On July 14, 2016, Monarch Utilities I, L.P. (Monarch) filed a joint motion to sever rate case expenses. Joining in the motion were Commission Staff, and Texans Against Monopolies' Excessive Rates (TAMER). The Office of the Public Utility Counsel (OPUC) did not oppose the motion. As of July 22, 2016, no party has filed an objection to the motion. The joint motion to sever rate case expenses is granted. The issue of rate case expenses is severed from this case and will be addressed in a separate docket as identified in this order.
