COMES NOW, the Steering Committee of Cities Served by Oncor ("Cities") and files this Motion to Intervene. In support of its Motion, Cities show as follows:

1. Cities are municipalities located within the service territory of Oncor Electric Delivery Company, LLC ("Oncor"). A list of Steering Committee Cities is included as Attachment A.

2. On October 31, 2016, Oncor filed an application for regulatory approval of the sale and transfer of ownership of Oncor. Cities as well as their residents and businesses may be adversely impacted by the relief requested by Oncor. Therefore, Cities have a justiciable interest in this proceeding.

3. Additionally, Cities have standing to participate in this proceeding pursuant to Public Utility Regulatory Act ("PURA") § 33.025.<sup>1</sup>




