Enclosed are ten (10) copies of my Rate Protest form concerning P.U.C Docket No. 46245 and the water and sewer rate increases proposed by Double Diamond Utilities Company of Dallas, Texas servicing The Cliffs Resort on Possum Kingdom Lake to be effective October 1, 2016.

The basis of my protest is that the justification for the rate increase is unclear. I have scanned through the 250 pages of documents at [interchange.puc.texas.gov](http://interchange.puc.texas.gov) and did not find the information that was clear to me. The documentation that may have provided an answer was labeled Confidential and could not be viewed. The justification for the significant increase in both sewer and water rates should be easily summarized, transparent and easily determined to be justifiable if that is the case.

In summary this request for rate increases for sewer and water should be denied until the justification is made clear to the customers.
