TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

Applicant, Double Diamond Utility Company, Inc. ("DDU") files this Agreed Motion to Modify Procedural Schedule, Extend Effective Date and Establish Relate Back Date, and in support thereof, respectfully shows as follows:

As a result of the assignment of a new attorney for the Commission Staff to this case, the parties engaged in discussions to modify the procedural schedule. The parties have reached an agreement regarding changes to the procedural schedule and request that the Administrative Law Judge issue an order adopting the procedural schedule attached as Exhibit "A". In addition, DDU requests, and the other parties agree, to extend the suspended effective date of the proposed rates from February 21, 2018, to April 1, 2018, and establish an agreed "relate back" date of February 21, 2018, for purposes of determining refunds or surcharges depending upon the outcome of the case.
