UNOPPOSED MOTION FOR CONTINUANCE**

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

Applicant, Double Diamond Properties Construction Co. d/b/a Rock Creek ("DDPC"), files this Unopposed Motion for Continuance, and in support thereof, respectfully shows as follows:

I.

Order No. 2, issued on October 20, 2016, was the initial order that established the procedural schedule and hearing date for this proceeding. The deadlines have been extended, and the hearing continued, on several occasions based on requests of DDPC as well as the Rock Creek Homeowners ("RCH"). The current schedule and hearing date is set out in SOAH Order No. 15, issued on August 15, 2017. The parties are negotiating in good faith and have made progress towards a settlement, however, additional time is needed to continue the discussions and finalize an agreement. DDPC respectfully requests a 30 day extension of all deadlines set out in Order No. 15, as follows:

Replies to Objections to rebuttal testimony	December 13, 2017


The parties will provide the ALJ with three agreed upon dates for the hearing on the merits no later than November 10, 2017.




