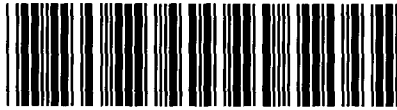

IN RESPONSE TO SOAH ORDER NO. 5**


In response to Order No. 5, Liberty Utilities (Tall Timbers Sewer) Corp., Liberty Utilities (Woodmark Sewer) Corp., and Liberty Utilities (Sub) Corp. ("Liberty Utilities") file this list of pending discovery disputes that remain to be resolved:

- Liberty Utilities' Objections to Tyler's Third Requests for Information. Filed on February 13, 2017.
- Liberty Utilities' Objections to City of Tyler's Request for Change in Designation. Filed on March 1, 2017.

Additionally, as reflected in SOAH Order No. 4, the then-presiding ALJ required Liberty Utilities to respond to her suggestion that certain information designated as highly sensitive at the time of the prehearing conference in this docket is merely "confidential" material sufficiently protected as such by the standing protective order. Liberty Utilities timely filed a response as required and the issue was subsequently briefed by all parties as SOAH Order No. 4 permitted. No further action was ordered and Liberty Utilities requests a ruling that no further action in response to the ALJ's suggestion is required.


