Additionally, as reflected in SOAH Order No. 4, the then-presiding ALJ required Liberty Utilities to respond to her suggestion that certain information designated as highly sensitive at the time of the prehearing conference in this docket is merely "confidential" material sufficiently protected as such by the standing protective order. Liberty Utilities timely filed a response as required and the issue was subsequently briefed by all parties as SOAH Order No. 4 permitted. No further action was ordered and Liberty Utilities requests a ruling that no further action in response to the ALJ's suggestion is required.
