



Please reference Liberty response to Tyler 1-39 (LU000887-000889)(Flow projections Summary): Admit or deny that the growth projections contained in this document do not consider the impact of the cost of utilities on population growth, home sales, or property values.

RESPONSE:

Based on conference with OPUC's counsel, Liberty Utilities was instructed to replace the word "impact" with "effect". Liberty Utilities was also instructed to replace "the cost of utilities" with "the proposed rate increase."

Thus, the revised OPUC RFI 7-1 request is:

Admit or deny that the growth projections contained in this document do not consider the effect of the proposed rate increase on population growth, home sales, or property values.

Liberty Utilities responds to the revised OPUC RFI 7-1 request as follows:

Cannot admit or deny. The flow projections summary referenced in this request was prepared by a licensed professional engineer. evaluating and determining growth projections, it is not standard practice for engineers to evaluate the potential effect of a proposed rate increase on population growth, home sales or property values. In evaluating growth projections, any attempt to determine the potential effect of a possible rate increase on population growth, home sales or property values would be speculative. The flow projections summary speaks for itself in terms of growth projection assumptions considered. Liberty Utilities is not aware of any demonstrated study showing that a proposed rate increase would negatively impact population growth, home sales or property values. It also should be noted that the licensed engineer was aware of the proposed rate increase at the time the document was prepared. Further, the basing of growth projections on the speculative possible effect of a rate increase on population growth, home sales or property values would not have permitted reliable or proper design methodologies needed for compliance with TCEO rules. See 30 TAC § 217.34. The consultant who prepared the referenced document properly relied on both the historic population growth rate and historic flow data for design purposes.

OPUC RFI 7-2 Please reference Liberty response to Tyler 1-39 (LU000887-000889)(Flow

projections Summary): Admit or deny that the proposed rate increase could have a negative effect on the growth projections contained in this document.

RESPONSE: Based on conference with OPUC's counsel, Liberty Utilities was instructed

that for purposes of this request the word "negative" should mean "dampening, lessening, reducing, or diminishing, meaning the population will not grow at the rate or to the level predicted." Thus, Liberty Utilities

responds using this clarified meaning as follows:

Cannot admit or deny. The Company cannot answer this question. There are many factors that drive population growth in a particular area besides a single utility's proposed service rates. Further, this issue is not relevant to

ratemaking in this docket.
