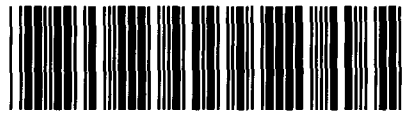

**JOINT NOTICE OF STIPULATION**

COME NOW Liberty Utilities (Woodmark Sewer) Corp., Liberty Utilities (Tall Timbers Sewer) Corp, and Liberty Utilities (Sub) Corp. ("Liberty Utilities" or "Applicants"), and, together with the agreement of the City of Tyler ("Tyler"), Office of Public Utility Counsel ("OPUC"), Public Utility Commission of Texas Staff ("Staff") and Intervenor ratepayers represented by Ms. Katherine Carter ("Intervenors") (collectively, the "Joint Parties"), file this Joint Notice of Stipulation ("Joint Notice"). In support, Applicants respectfully show the following.

**I. BACKGROUND**

On September 2, 2016, Liberty Utilities filed this application to change sewer rates. On July 25, 2017, all parties to the proceeding announced to the presiding SOAH ALJ that they had reached an agreement in principle and subsequently moved to abate while a unanimous stipulation and settlement agreement was developed to resolve this docket.


**II. NOTICE OF UNANIMOUS STIPULATION AND SETTLEMENT AGREEMENT**

With this Joint Notice, the Joint Parties are filing a Unanimous Stipulation and Settlement Agreement ("Stipulation") dated November 14, 2017 with agreed proposed tariffs attached. However, under the terms of the Stipulation, the Joint Parties may decide to change the rates in the tariffs to volumetric rates at some point during the next few months to be reflected in a final

Commission order and final tariffs. Thus, the Joint Parties will supplement this Joint Notice at a later date, provide a proposed final order, submit evidence for admission into the record in support of the Stipulation, and request remand to the Commission for final approval at the appropriate time. In the meantime, this docket should remain abated as previously ordered.


